(Initial) The Women's Civic Club of PCB is considered an event organizer and is required to secure a Special Event Permit, which requires submission of a list of all vendors. Upon completion of the event, each vendor must submit a Business Tax Receipt (BTR) reflecting the vendor's gross sales & payment of the 1% City Business License Tax. This 1% tax is separate from any sales tax due to the state. (For instance, if you have \$500.00 in sales, you would owe \$5.00 when filing the BTR. When paid the day of the event, there is a 3% discount for a total example payment total \$4.85.) You will be supplied with instructions and the form to report & pay the 1% City Business Tax. You may submit this to the event organizer at the close of the event.
